

Based on Article 98 of the Law on Higher Education ("Official Gazette of the Republic of Serbia", No. 88/2017, 73/2018, 27/2018 - other laws, 67/2019, 6/2020 - other laws, 67/2021, 76/2023 and 19/2025), Article 85 of the Statute of the University of Belgrade ("Official Gazette of the University of Belgrade", No. 201/2018, 207/2019, 213/2020, 214/2020, 217/2020, 230/2021, 232/2022, 233/2022, 236/2022, 241/2022, 243/2022, 244/2023, 245/2023, 247/23, 251/23, 258/24, 260/25 and 262/25), the Regulation on the Enrollment of Students in Study Programs of the University of Belgrade ("Gazette of the University of Belgrade", No. 208/2019, 212/2019, 241/2022 and 252/24), the Regulation on the Method of Determining the Status of Candidates and Students with Disabilities ("Gazette of the University of Belgrade", No. 234/2022 and 238/2022) and the Decision of the Senate of the University of Belgrade on the Announcement of the Call for Student Enrollment of April 15, 2026, the University of Belgrade is announcing a unified

THE CALL

FOR STUDENT ENROLLMENT IN MASTER ACADEMIC STUDIES AT THE FACULTIES OF THE UNIVERSITY OF BELGRADE IN THE ACADEMIC YEAR OF 2026/2027

STUDY PROGRAMME

The study programmes of master academic studies contain compulsory and elective courses in the total scope of at least 60 ECTS credits.

GENERAL REQUIREMENTS OF THE CALL

A person who has completed academic studies at an accredited higher education institution and study program may enroll in the first year of master academic studies:

1. in the scope of at least 60 ECTS credits, when previously completed:
 - a) undergraduate academic studies in the scope of 240 ECTS credits;
 - b) undergraduate academic studies in the scope of 180 ECTS credits and completed master academic studies in the scope of 120 ECTS credits;
 - c) undergraduate academic studies in the scope of 180 ECTS credits and completed master academic studies abroad in the scope of 60 ECTS credits;
2. in the scope of at least 90 ECTS credits, when previously completed undergraduate academic studies in the scope of at least 210 ECTS credits;

3. in the scope of at least 120 ECTS credits, when undergraduate academic studies in the amount of at least 180 ECTS credits have been previously completed.

A person who has completed integrated studies and achieved at least 300 ECTS credits may also enroll in the first year of master studies.

A person who has acquired higher education according to the regulations that were valid until the date of enactment of the Law on Higher Education ("Official Gazette of the Republic of Serbia", No. 76/2005, 100/2007 - authentic interpretation, 97/2008, 44/2010, 93/2012, 89/2013, 99/2014, 45/2015 - authentic interpretation, 68/2015 and 87/2016) has the right to enroll in master academic studies under the conditions and in the manner prescribed by the Regulations on the Enrollment of Students in Study Programs of the University of Belgrade and the general act of the faculty, as follows:

1. a person who has acquired higher education lasting at least eight semesters has the right to enroll in master academic studies in the scope of at least 60 ECTS credits.
2. a person who has completed higher education in a duration of less than eight semesters has the right to enroll in master academic studies in the scope of at least 120 ECTS credits.

The study program of master academic studies determines which undergraduate academic study programs are appropriate for continuing studies in a particular study program.

Persons who completed their previous studies no later than October 14, 2026 can apply for the call.

In exercising the right to enroll in a study program, candidates have equal rights that cannot be restricted on the basis of gender, race, marital status, skin color, language, religion, political opinion, national, social or ethnic origin, disability or other similar grounds, position or circumstances.

CRITERIA FOR DETERMINING THE ORDER OF CANDIDATES AND MANNER OF SCORING

The order of candidates for enrollment in the first year of master academic studies is determined on the basis of the overall average grade, the length of study, results achieved at the entrance exam - if such an exam is organized and other special conditions published in the call for each individual study program, and in a manner determined by the general act of the Faculty, University.

For candidates who have completed undergraduate or integrated studies, the average grade achieved in those studies, the length of study and other conditions prescribed by the general act of the Faculty are taken.

For a person who has completed master academic studies - the overall average grade of study (OAG) is calculated on the basis of the average grades of study in undergraduate studies (GrUS) and master academic studies (GrMS), weighted by the duration of the study programme in undergraduate and master academic studies expressed in ECTS (UScredit and MScredit):

$$\text{Overall Average Grade (OAG)} = \frac{\text{GrUS} \times \text{UScredit} + \text{GrMS} \times \text{MScredit}}{\text{UScredit} + \text{MScredit}}$$

For a person who has acquired higher education according to the regulations that were valid until the date of enactment of the Law on Higher Education ("Official Gazette of the Republic of Serbia", No. 76/2005, 100/2007 - authentic interpretation, 97/2008, 44/2010, 93/2012, 89/2013, 99/2014, 45/2015 - authentic interpretation, 68/2015 and 87/2016), the average grade from undergraduate studies, which includes the diploma thesis, if any, is evaluated.

When compiling the ranking list of candidates applying for enrollment in studies, the higher education institution first ranks candidates who are enrolling for the first time at that level of study and at that higher education institution, and then ranks the other candidates.

DEADLINES AND MANNER OF FILING COMPLAINTS

Faculties publish lists of registered candidates, with data on points based on previous education, on the notice board and website, to which candidates can submit comments in case of technical errors within a deadline set by the faculty. After that deadline, data that imply success at previous levels of education are considered final.

After the entrance exam, faculties publish a preliminary ranking list for each individual study program, on the notice board and the faculty website within a deadline set by the Call.

A candidate may file a complaint regarding the regularity of the procedure established by the call, the regularity of the previous aptitude test, the regularity of the entrance exam or his/her place on the ranking list within 36 hours of the publication of the preliminary ranking list at the faculty.

The appeal is submitted to the competent faculty commission, or the University commission for enrollment in studies at the University, which issues a decision on the appeal within 24 hours of receiving the appeal.

The candidate has the right to file an appeal in the second-instance procedure to the dean of the faculty, or the rector, within 24 hours of the expiration of the deadline for issuing a decision by the faculty commission on the candidate's appeal.

The dean, or the rector, issues a final decision within 24 hours of receiving the appeal and delivers it to the candidate and the Faculty, or the University commission.

After deciding on the appeal, the faculty determines and publishes the final ranking list of all candidates with the total number of points earned according to all criteria for each study program and delivers it to the University.

The University publishes the final ranking lists for each study program on the official website of the University, after which the candidate is enrolled.

STUDENT ENROLLMENT

A person has exercised the right to enroll if he or she is on the ranking list within the number specified in the call for enrollment.

A candidate may enroll in a study program as a student financed from the budget of the Republic of Serbia (budget student) if he or she is on the final ranking list up to the number approved for enrollment of candidates at the expense of the budget.

A candidate may enroll in a study program as a self-financed student (self-financing student) if he or she is on the final ranking list up to the number determined for enrollment of self-financing students.

ENROLLMENT OF FOREIGN STUDENTS

A foreign citizen may enroll in a study program under the same conditions as a domestic citizen.

A foreign citizen pays tuition fees throughout the entire period of study, unless otherwise specified by an international agreement.

When applying for the call, a foreign-citizen candidate shall submit a [decision on the recognition of a foreign higher education document](#) or a confirmation that the procedure has been initiated if the higher education document on previous education was acquired abroad.

Persons who possess a foreign higher education document must begin the recognition procedure for the purposes of continuing education no later than **fifteen days** before the deadline set by the faculty for application to the call.

Foreign documents submitted after these deadlines will only allow for application for enrollment in the following school year.

Before enrollment, a foreign citizen candidate is required to submit evidence to the faculty/university:

- that he/she is health insured for the school year he/she is enrolling in;
- to be fluent in the Serbian language or the language in which the study program is conducted.

ENROLLMENT OF SERBIAN CITIZENS WHO HAVE COMPLETED PREVIOUS EDUCATION ABROAD

A Serbian citizen who has completed his/her previous education abroad may apply for admission to a study program if he/she has a [decision on the recognition of a foreign higher education qualification for the purpose of continuing education at the University of Belgrade](#) and the enrollment in a specific study program. If the recognition procedure has not been completed, these candidates must submit a confirmation with their application that the procedure is ongoing.

Persons who possess a foreign higher education qualification must begin the recognition procedure for the purpose of continuing education no later than **fifteen days before the deadline** set by the faculty for the application to the call.

Foreign documents submitted after these deadlines will allow for enrollment only in the following school year.

ENROLLMENT OF PERSONS WITH DISABILITIES

A candidate applying for enrollment in a study program as a candidate with a disability, or for enrollment through the Affirmative Action Program for Enrollment of Persons with Disabilities, when

applying for enrollment in the desired study program, submits, in addition to the mandatory application documentation, an opinion on determining the status of a candidate with a disability.

The deadline for initiating the procedure for determining the status of a candidate with a disability is **June 10, 2026**.

The procedure is initiated by submitting a [request](#) for determining the status of a candidate with a disability to the Office for Students with Disabilities, on the prescribed form, and in accordance with the Regulation on the Method of Determining the Status of Candidates and Students with Disabilities.

Persons with disabilities may take the [entrance exam in a manner adapted to their capabilities](#), or in a form accessible to them, and in accordance with the objective capabilities of the faculty.

In order to exercise the right to an adjustment in the entrance exam, a person with a disability is obliged to explain in writing how the entrance exam needs to be adjusted and submit this explanation when applying for the call for admission to the study program.

ENROLLMENT OF MEMBERS OF ROMA NATIONAL MINORITY

Candidates belonging to the Roma national minority can also apply for admission to study programs at the University of Belgrade through the Affirmative Action Program for Enrollment, which is implemented by the Ministry. This program includes support for candidates when enrolling in a study program, as well as during their studies.

Information on the enrollment of candidates belonging to the Roma national minority is available in the [Affirmative Action Program for Enrollment of Members of the Roma National Minority](#).

When applying, these candidates submit to the faculty, in addition to the prescribed documentation, a [Statement that they are members of the Roma national minority](#) and a [Recommendation from the National Council of the Roma National Minority](#).

ENROLLMENT OF MEMBERS OF THE SERBIAN NATIONAL MINORITY FROM NEIGHBORING COUNTRIES

Members of the Serbian national minority from neighboring countries, including scholarship holders of the "Serbia for Serbs from the Region" Program, in the 2026/2027 school year may enroll in the first year of studies under the same conditions as citizens of the Republic of Serbia, including the right to budget financing.

Neighboring countries are: Hungary, Romania, the Republic of Bulgaria, the Republic of North Macedonia, the Republic of Albania, Bosnia and Herzegovina, the Republic of Slovenia, the Republic of Croatia and Montenegro.

When applying for the call, these candidates, in addition to the prescribed documentation, submit a written [statement](#) that they are members of the Serbian national minority.

A member of the Serbian national minority from a neighboring country, who is a scholarship holder of the "Serbia for Serbs from the Region" Program, when submitting an application and the

prescribed documentation for enrollment in studies, also submits to the higher education institution a certificate from the Ministry of Education on the status of a scholarship holder.

CALL FOR ADMISSION – SCHEDULE

First enrollment period

- Candidate registration: from **September 1 to October 5, 2026**, according to the schedule;
- University publishes the final rankings by study programs that are the basis for enrollment: **no later than October 12, 2026**;
- Enrollment of the candidates: **no later than October 15, 2026**, after the publication of the final ranking list of the University, and according to the schedule;

After the enrollment is complete, and **no later than October 16, 2026**, the faculties submit to the University the number of enrolled students by study program and the remaining number of vacant places.

Second enrollment period

- Candidate registration: from **October 19 to October 20, 2026**, according to the schedule;
- University publishes the final rankings by study programs that are the basis for enrollment: **no later than October 26, 2026**;
- Enrollment of the candidates – **no later than October 28, 2026**, after the publication of the final ranking list of the University, and according to the schedule;

After the enrollment is complete, and **no later than October 29, 2026**, the faculties submit to the University the number of enrolled students by study program and the remaining number of vacant places.

Third enrollment period

Enrollment within the third enrollment period will be carried out only for study programs for which the faculty submits a request to organize this period.

- **no later than November 5, 2026** - the University publishes the final rankings by study programs that are the basis for enrollment;
- **no later than November 7, 2026** - the faculties submit to the University the number of enrolled students by study programs and the number of vacant places.

The call for enrollment in joint study programs in which the University or a faculty within the University participates is announced in accordance with the deadlines defined in the partnership agreement on the implementation of the study program.

The calendar may be changed later, in accordance with the circumstances.

Candidates submit applications for the call through the student services of the faculties where the study program is conducted.

OTHER PROVISIONS

When applying for the call, candidates must submit original documents for inspection, and together with the application form, they must submit photocopies of the following documents:

- diploma and diploma supplement, i.e. certificate of completion of the first-cycle study program;
- decision on the recognition of a foreign higher education certificate or confirmation that the recognition procedure for the purpose of continuing education has been initiated (only for candidates who have a foreign higher education certificate);
- proof of payment of the application fee;
- other evidence, if necessary.

When applying for the call a diploma and diploma supplement, i.e. certificate of graduation with a certificate of passing exams issued by an accredited higher education institution and study program, are submitted.

A candidate who completed his studies according to the regulations that were valid before the adoption of the Law on Higher Education ("Official Gazette of the Republic of Serbia", No. 76/2005, 100/2007 - authentic interpretation, 97/2008, 44/2010, 93/2012, 89/2013, 99/2014, 45/2015 - authentic interpretation, 68/2015 and 87/2016) must submit a certificate of passed exams with his diploma, instead of a diploma supplement.

A candidate who has not been issued a diploma, upon enrollment, must submit a certificate of graduation with a certificate of passed exams, provided that, no later than within one year, he delivers the diploma and the diploma supplement to the Faculty or University on the completed previous level of higher education.

A diploma of completed first level of higher education in academic studies, which the candidate has acquired with the recognition of part of the study program of professional studies of the first level, is considered valid for enrollment in the second and third levels of studies only if the volume of recognized exams from the study program of professional studies does not exceed 30% of the total volume of the study program of academic studies in which the diploma was acquired (72/240 ECTS credits, or 54/180 ECTS credits in accordance with the Regulation on Standards and Procedure for Accreditation of Study Programs).

The University or Faculty implementing the study program in which the candidate is enrolled is obliged to check the submitted higher education documents and if it determines that the document was not issued in accordance with applicable regulations, the candidate is not entitled to enroll.

If it is subsequently determined that the document of completed previous level of studies has deficiencies, the enrollment cancellation procedure is carried out, in accordance with the Law.

Also, the candidate provides a [statement authorizing the Faculty and the University](#) to inspect, obtain and process personal data for the purposes of the admissions process and for the purpose of studying; that personal data may be imported into an electronic database, that may be used for the purposes of generating the necessary statistical data, submitting the requested data to the Ministry of Education, and that they will not be accessible to unauthorized persons.

All candidates must also submit a signed [statement](#) when applying that they were not enrolled in a budget status at the level of study for which they are applying.

All candidates must also sign a [statement](#) that they are enrolling for the first time in the level of study for which they are applying and the higher education institution to which they are applying.

For the costs that the Faculty/University has in connection with the implementation of the call, candidates pay a fee to the Faculty/University's bank account, in the amount determined by the Faculty/University.

Candidates who obtain the right to enroll submit:

- certified photocopies of documents and original documents for inspection,
- an extract from birth certificate (the faculty, i.e. the University, obtains an extract from the birth certificate *ex officio*, except for foreign citizens who are obliged to submit this document);
- completed form ŠV-20 (the form is also completed electronically, and the printed version is signed and submitted to the faculty);
- index (if the faculty does not provide indexes),
- two photographs of 4.5x3.5 cm,
- proof of payment of the fee for enrollment costs (if a fee is provided),
- proof of payment of tuition fees (or part of the tuition fees) for self-financing students,
- proof of payment of the fee for the University Center for Career Development and Student Counseling,
- other evidence as needed.

For candidates who completed their previous level of studies abroad, it is necessary to submit a decision of the rector on the recognition of a foreign public higher education certificate upon enrollment.

A candidate who has acquired the right to enroll but does not enroll within the prescribed deadline, loses the right to enroll and the next candidate will be enrolled in his place according to the established order.

NOTE:

The University of Belgrade reserves the right to amend and supplement the text of the Call as well as the General Provisions for Enrollment in Studies. Any possible amendments to the Call will be published on the official website of the University of and the relevant faculties. All detailed information can be found on the websites of the faculties.
